## **Description:**

57 North Main Street is a one-and-a-half-story tall, three-bay wide, two-bay deep, frame commercial building constructed circa 1945. A one-story, three-bay, front-gabled addition extends to the northwest. The front-gabled roof has a very gentle slope; it is sheathed with asphalt shingles and aluminum-clad eaves. An exterior brick chimney pierces the roof on the southwest slope of the main block. The exterior of the building is clad in wood clapboard siding. The second floor has no windows; previous windows were sealed in the late twentieth century. The first floor is sheltered by a pent roof with asphalt shingles. The commercial entrance consists of a central canted door with nine inset lights over two panels opening below a transom. Flanking the entrance are large display windows with twenty-four inset lights facing the street and twelve on the canted wall area. The northeast elevation is void of any openings. The rear elevation, clad in wood clapboard siding and wood plank siding, is pierced by a single metal door with a one-over-one, vinyl hopper window above. A concrete stoop with metal railings provides access to this secondary entrance. The southwest elevation is void of any openings. The character-defining element of the building is its display window and entrance.

History: 57 North Main Street once served as a Cumberland Farms convenience store on the first floor with an apartment on the second floor. The apartment was sealed in the late twentieth century following a structural fire. 57 North Main Street does not appear on any historic maps. According to historic aerial photographs, the subject building was constructed circa 1945. 57 North Main Street currently contains a restaurant.
