Description:

PS&S recommends that 4 Symmes Court, constructed in 1920 and extensively altered, is a non-contributing property in the Cranbury Historic District.

The 2 ½-story, hipped-roof main block of this clapboard and painted wood shingle-clad, frame dwelling on a covered foundation is 2 bays wide and 3 bays deep and is fronted on its south elevation by a 1-story, hipped-roofed porch that projects beyond the east elevation. A 2-story, hip-roofed, altered side volume projects to the west from the main volume and is fronted on the south by a 1-story, hipped-roofed enclosed porch. The altered rear volume is in 1 and 2 stories. A hipped-roofed dormer is located on the south roof slope. The roofs throughout are clad in asphalt shingle and include exposed rafter tails. An exterior brick chimney is roughly centered on the east elevation. The windows throughout have replaced sash. The first floor is clad in clapboard and the second floor is clad in painted wood shingle. The front porch includes historic columns and is accessed by a stair in the west bay and by a brick stair on the east side. The primary entrance, located in the west bay, includes a single-light door. The remaining bays of both floors are lighted by a double window. A triple window lights the 1-story side volume. The east, side elevation is regularly fenestrated, with a double window in the south bay of the first floor. The west, side elevation is asymmetrically fenestrated on the first floor and regularly fenestrated on the second floor. The north, rear elevation is not visible from the public right-of-way. The 1 ½-story, gable-roofed garage, located to the northeast of the residence, includes paired segmental 6-light, replaced garage doors and is lighted on the upper floor by a triple 6-light awning window fronted by a historic

window box with shaped brackets.

Symmes Court, named for a local parson, occupies land previously owned by the Presbyterian Church and sold and planned for subdivision in 1894. The 1980 National Register of Historic Places Nomination for the Cranbury Historic District reports that the 2 1/2-story, hipped-roofed residence at 4 Symmes Court was constructed by Lewis Bowers in 1920. The residence is documented on the 1933 Sanborn map as a 2-story, rectangular-plan dwelling with a 1-story front porch, a 1-story rear el, and a 2-story side volume with a 1-story front porch. A 2-story garage is located to the northeast of the residence. Aerial photographs show that a large 2-story volume was added to the west side and rear of the residence and the garage was doubled in size between 2010 and 2012. The 1974 photographic inventory of Cranbury historic buildings in the collection of the Cranbury Historical and Preservation Society shows that the side porch was enclosed sometime in the mid-20th century.

The residence at 4 Symmes Court is a non-contributing property in the Cranbury Historic District because of multiple alterations after the period of significance that have replaced the vast majority of historic exterior materials and distorted the historic massing of the house.

Setting:

Symmes Court is a short residential street that connects South Main Street, to the southeast, to Cranbury Neck Road, to the southwest. The residences of this tree-lined street are single family dwellings of moderate size.

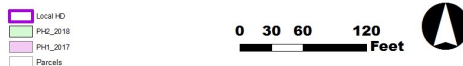
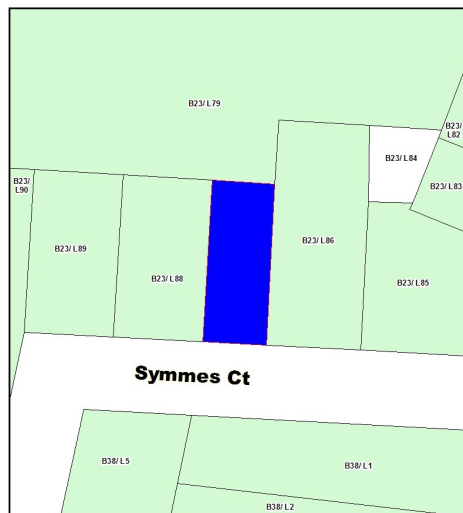
